

RULEMAKING UPDATE

In accordance with the provisions of the Administrative Procedure Act (R.S. 49:957), the Louisiana Addictive Disorder Regulatory Authority hereby announces its proposed rule change. [Notice of Intent](#) was published on pages 1459-1474 of the Louisiana Register, Vol. 51, No. 9 on September 20, 2025.

The Louisiana Addictive Disorder Regulatory Authority intends to amend LAC 46:LXXX §§ 101, 103, 105, 301, 303, 503, 701, 703, 705, 707, 709, 711, 713, 719, 721, 723, 725, 727, 729, 731, 901, 903, 905, 908, 909, 911, 913, 921, 923, 925, 927, 1101, 1301, 1501, 1503, 1505, 1507, 1511, 1705, 1707 and 1709; and to repeal LAC 46:LXXX §§ 505, 715, 717, 1701, 1703, 1901, 1903 and 1905; and to adopt and enact LAC 46:LXXX §2001 regarding conduct of meetings with allowed participation of certain individuals by teleconference, video conference or alternative means, as required by R.S. 42:14 E(I); to adopt and enact LAC 46:LXXX §2101 regarding telehealth as required by R.S. 40:1223.4A; and to adopt and enact LAC 46:LXXX §715.1, regarding licensed prevention professionals, LAC 46:LXXX §715.2 regarding certified prevention professionals, and LAC 46:LXXX §715.3 regarding registered prevention professionals, and LAC 46:LXXX §720 regarding certified prevention supervisors, all as required by R.S. 37:3387.10 (E), R.S. 37:3387.11 (E), R.S. 37:3387.12(E), and R.S. 37:3387.14(B), respectively; all in order to remove statements of law from the rules; to coordinate and clarify all rules regarding each practice credential, specialty certification, or learning status within the same rule; to adhere to the requirements of Executive Order JML 25-38 to conduct a systematic review of all rules, to remove unnecessary regulatory barriers, to promulgate all rules required by law, to address costs and benefits of regulatory alternatives; to ensure that all rules are written using plain language; and to ensure that all rules are necessary, consistent with the law, and aligned with the mission of the ADRA.

These changes were adopted by the Louisiana Addictive Disorder Regulatory Authority Board at its meeting of July 27, 2025.
